



**MEMORANDUM OF UNDERSTANDING
BETWEEN
PUKYONG NATIONAL UNIVERSITY,
BUSAN, REPUBLIC OF KOREA
AND
THAMMASAT UNIVERSITY,
BANGKOK, THAILAND**

This memorandum of understanding (MOU) is between Pukyong National University, located in Busan, Republic of Korea, and Thammasat University, located in Bangkok, Thailand. When signed by authorized representatives of both universities, this MOU will evidence their intent to pursue cooperation for mutual benefits.

I. Objective

The objectives of this MOU, executed in 2 copies in English, are to outline the possible ways through which Pukyong National University and Thammasat University could foster academic and educational collaboration and to define the terms of mutual agreement.

II. Scope of Activities

The two universities agree to establish collaborative relationships in the following areas:

1. Faculty and administrative staff exchange;
2. Student exchange at graduate and undergraduate levels;
3. Development of joint educational programs;
4. Joint research activities and exchange of academic information and publications;
5. Organization of academic conferences, seminars, and symposia;
6. Other forms of educational activities deemed beneficial to both parties.

The specific areas and details of cooperation within the framework of this MOU shall be discussed and agreed upon in writing by the appropriate authority of each university prior to the initiation of any particular program or activity.

III. General Provisions

1. Regulations

Each party agrees to collaborate in good faith to ensure that all activities and projects undertaken under this MOU will be conducted in a manner that will allow each institution to comply fully with the applicable laws, regulations, and policies.

2. Costs

Except as otherwise agreed upon by both universities in writing, all expenses incurred by each party in connection with the preparation and negotiation of this MOU, the detailed agreements contemplated herein, and all actions undertaken in accordance herewith, will be borne by the party incurring such costs.

3. Term and Termination

This MOU will remain effective for five (5) years and shall be renewed by mutual consent every five (5) years. Amendments to this MOU may be requested, in writing, by either party and approved by the authorized signatories.

Either party may request termination of this MOU by giving the other a written notice of its desire to terminate six (6) months prior to the proposed termination date. Early termination shall have no effect on the activities already in progress as of the date of notification of termination.

LETTER OF INTENT

PUKYONG NATIONAL UNIVERSITY, BUSAN, REPUBLIC OF KOREA, denominated as “PKNU”, represented by the “ Division of International and Area Studies, College of Humanities and Social Sciences” and THAMMASAT UNIVERSITY, BANGKOK, THAILAND, denominated as TU, represented by the “College of Interdisciplinary Studies”, in the agreement to establish this letter of intent based on common interest:

1. Both “PKNU” and “TU” recognize the importance of establishing relationships for the Campus Asia-AIMS Programme.
2. Both institutions have the intention to cooperate in two fields, “International Business” and “Language and Culture”.

INTENTION LETTER

Pukyong National University, Busan Republic of Korea, called "PKNU", represented by Professor P. D. Noh, Yongeok from the "Division of International and Area Studies, College of Humanities and Social Sciences" and the Campechano Institute, Campeche, Mexico, called "INSTITUTE" represented by its General Director of Postgraduate Studies and Research, M. Luis Fernando Góngora Carlo, agree to establish this letter of intent, on the following basis of common interests:

1. Both parties recognize the importance of establishing academic exchange and collaboration relationships.
2. The two institutions define as an objective to facilitate the ties of friendship, educational cooperation and research.
3. Both parties recognize as an area of academic collaboration those related to bibliographic exchanges and exchanges of researchers or professors, students, masters and doctoral students and the performance of joint studies in multiple areas of research that emanate from this exchange.

5. Both institutions agree to structure a specific collaboration agreement to strengthen ties in the next six (6) months from the date of signing this letter of intent.
6. Generate the lines and guidelines of the Work to establish the double degree, firstly, in the postgraduate courses, with the purpose of reaching the bachelor's degrees.
7. Organize online activities where Korean and Mexican Culture are promoted respectively

By signing this letter of intent, the two institutions, the "INSTITUTE" and the "PKNU", express their mutual satisfaction in joining efforts to develop the friendship between Mexico and Korea.
